Public consultation kicks off

On June 5, ASI started a public consultation period on all its Standards and Guidance, plus Assurance Manual and Claims Guide until 7 July, 2017. The consultation is an important phase in the Standards development process: feedback received will inform and lead into the pilot program, which will run from July to September this year. 2017 Consultation process

The ASI has opened a public consultation period for all stakeholders to review and comment on the current draft versions of the ASI Program normative documents:

- ASI Performance Standard – Version 2 and accompanying Guidance
- ASI Chain of Custody Standard – Version 1 and accompanying Guidance
- ASI Assurance Manual – Version 1
- ASI Claims Guide – Version 1

Key dates for consultation and finalisation of ASI's normative documents are:

- ASI Standards – public consultation on latest drafts of Performance Standard and CoC Standard – May-June 2017
- Pilot program – July-September 2017
- Indigenous Peoples Advisory Forum meeting – July 2017
- Standards Committee review of all feedback – September-October 2017
- Board Adoption of final Standards – target November/December 2017.
