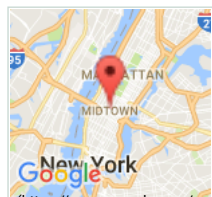

Anne M. Milgram (Trinity Hall 1993) (Moderator)

Professor of Practice and Founder & MD, Criminal Justice Innovation Lab, NYU School of Law

Prior to joining NYU, Milgram served as New Jersey's Attorney General from June 2007 to January 2010, where she headed the 9,000-person Department of Law and Public Safety. Milgram became Attorney General after serving as First Assistant Attorney General. As Attorney General, Milgram supervised eight divisions and multiple commissions and boards, including: the Division of Criminal Justice; the Division of Law; the Division of Consumer Affairs; the Bureau of Securities; the Division of Civil Rights; the Juvenile Justice Commission; the Division of Gaming Enforcement; the Division of Highway Traffic Safety; the Racing Commission; and the Division of Alcoholic Beverage Control. Milgram also supervised the Division of the New Jersey State Police and its 3,000 sworn members and the Camden Police Department.

Milgram served as the state's Chief Law Enforcement Officer, overseeing and directing the 21 New Jersey county prosecutors and the approximately 30,000 state and local law enforcement officers. She spearheaded investigations into street gangs, public corruption, gun violence and trafficking, securities fraud, and mortgage fraud. She also implemented a statewide program to improve public safety through prevention of crime, criminal justice and law enforcement reform, and re-entry programs and services. As Attorney General, Milgram oversaw affirmative and defensive civil litigation for the state, providing legal representation to all state departments and agencies in approximately 25,000 civil matters each year. She also served as a member of the US Attorney General's Executive Working Group on Criminal Justice and as a co-chair of the National Association of Attorneys General Criminal Law Committee.

Previously, Milgram has served as Counsel to United States Senator Jon S. Corzine; a federal prosecutor in the Criminal Section of the United States Department of Justice's Civil Rights Division; and the lead federal prosecutor in the country for human trafficking crimes. Milgram began her prosecution career as an Assistant District Attorney in the Manhattan District Attorney's office.

She graduated summa cum laude from Rutgers College with a degree in English and political science, and received a masters of philosophy degree in social and political theory from the University of Cambridge. She received her law degree from New York University School of Law and clerked for United States District Court Judge Anne E. Thompson in Trenton.

Fiona Cousins, PE, LEED AP BD+C (Trinity Hall 1986)

Principal, Arup

Fiona Cousins leads the Sustainability team in Arup's New York office and is also a leader of the Mechanical engineering team. She directs technical investments for Arup's Americas Region and is a member of Arup's Americas Board. Fiona is a mechanical engineer by profession and has spent much of her career engaged in HVAC design, with an area of specialization in thermal comfort and energy efficiency. She has extensive project experience and has worked for both corporate and institutional clients on a wide range of building, planning and sustainability projects including museums, galleries, archives, trading floors, laboratories, libraries, performing art centers, and campuses.

Fiona is a frequent presenter on transformative sustainable building design and has presented technical papers in the areas of low-energy design and sustainability. Fiona is a LEED® Accredited Professional and has led a number of projects pursuing the highest levels of LEED goals. Fiona served as the chair of the New York Chapter of the USGBC (Urban Green) for two years. She is currently chair of the USGBC.

Alison North, PhD (Selwyn 1983)

Research Associate Professor and Senior Director, Bio-Imaging Resource Center

Dr. North joined The Rockefeller University in 2000 to establish and direct its Bio-Imaging Resource Center, one of the world's most comprehensive facilities for state-of-the-art microscopy and scientific imaging. Dr. North, a cell biologist whose research has included using immunoelectron microscopy to study muscle defects caused by Duchenne muscular dystrophy and ultrastructural studies of the cellular organization of epidermal cell-cell junctions, advises and trains hundreds of researchers from Rockefeller and other institutions in a wide variety of optical microscopy techniques.

A native of Yorkshire, UK, she was an undergraduate at the University of Cambridge and received her doctorate from Oxford University. She undertook postdoctoral research in Salzburg and then Manchester, where she was later awarded a Wellcome Trust Career Development fellowship. Dr. North's images and movies have been exhibited worldwide, including in science exhibits at the International Center of Photography in New York and on the public television science series Nova. She has also acted as judge for both the Olympus BioScapes and Nikon Small World photomicrography competitions.



Kym Taylor, LLM (Sidney Sussex 2001)

Chief, Evaluations Team, Department of Peacekeeping Operations and Department of Field Support, United Nations, New York

Ms. Taylor joined the United Nations in 2005. She has held several different positions within the Department of Peacekeeping Operations, including in the Africa Division in the Office of Operations, the Under Secretary-General's Office, and the Division of Policy, Evaluation and Training. She has also worked for the United Nations peacekeeping operation in Darfur, Sudan and in the special political mission in Libya. She is currently the Chief of the Evaluations Team in the Department of Peacekeeping Operations and the Department of Field Support, based in New York. She leads and oversees evaluations that examine and assess the ability of peacekeeping operations to effectively implement Security Council mandates and to manage and administer their resources in accordance with United Nations policies. The results of evaluations inform the management, policy development, resource utilization and training activities of both Departments, strengthen the ability of Headquarters to provide strategic guidance to operations based on comprehensive assessments of performance, and allow for improved feedback on operational issues to Troop and Police Contributing Countries, Member States and legislative bodies.

Prior to working for the United Nations, Ms. Taylor worked as an Attaché in the Australian Permanent Mission to the United Nations, as an Advisor to the Commonwealth Attorney-General on human rights and international law issues, and as a commercial solicitor in Australia. Ms. Taylor studied at the University of Adelaide, acquiring a Bachelor of Arts and a Bachelor of Laws (Hons), before studying at the University of Cambridge where she obtained a Masters of Law with a focus on international law. Ms. Taylor was the recipient of a Chevening Scholarship, as well as a Queen's Trust Australia award.
